ZINC BORATE TREATMENT

Zinc borate provides protection against decay fungi/rot and Wood Destroying Organisms (WDO) such as termites, including the Formosan Subterranean Termite.

The treatment is mixed in with the strands, adhesives and wax to provide consistent protection throughout the entire board. There is no need to treat the boards before installation or to reapply treatment after it's been trimmed to size. Zinc borate does not affect the strength properties of the product after treatment.

Our ZB treated products are manufactured at Tolko's Athabasca mill and are approved for use as defined in AWPA U1, Use Category UC2. APA Product Report PR-N216 confirms that ZB treated T-STRAND OSB meets the performance requirements of PS 2.
