

Tolko T-STRAND Pro OSB STR 1 Sheathing

Transferable, 50 Year Limited Warranty [1]

Warranty Coverage

Subject to the limitations and exclusions provided below, Tolko Industries Ltd. ("Tolko") warrants to the builder ("Builder") who purchases and installs Tolko T-STRAND Pro OSB STR 1 Sheathing grade-stamped APA Structural 1 Rated Sheathing, in a building ("Building"), and to the initial owner-occupier ("Owner"), that the Tolko T-STRAND Pro OSB STR 1 Sheathing panels are manufactured to meet the applicable standards identified by the APA trademark stamped on the Tolko T-STRAND Pro OSB STR 1 Sheathing. When properly stored, handled, installed and maintained^[2] will not delaminate^[3] for a period of 50 years from the date of manufacture.

This limited warranty: (i) is transferrable for 50 years; (ii) applies only to Tolko T-STRAND Pro OSB STR 1 Sheathing manufactured after June 1, 2010 and (iii) supersedes any warranty issued prior to that date and otherwise applicable. Tolko T-STRAND Pro OSB STR 1 Sheathing is designated as Exposure 1 under the Product Standard 2 (PS2) in place at the time the panels were manufactured and are not suitable for permanent exposure to the weather or use in high moisture environments.

Limited and Exclusive Remedy

If a Tolko T-STRAND Pro OSB STR 1 Sheathing panel delaminates during proper installation or after proper installation because it is defective, Tolko will, in its sole discretion, offer one of the following exclusive remedies for claims covered by this warranty: (i) repair or replace the defective Tolko T-STRAND Pro OSB STR 1 Sheathing panels; or (ii) refund or credit the purchase price paid by the Builder for the Tolko T-STRAND Pro OSB STR 1 Sheathing panels, as evidenced by the original invoice. Tolko's total liability will not exceed three (3) times the original purchase price of the defective Tolko T-STRAND Pro OSB STR 1 Sheathing.

Reporting Claims

A warranty claim will only be honored if (i) Tolko is provided with written notification of the claim within thirty (30) days after the defect is first discovered, (ii) a Tolko representative, or a professional designated by Tolko, is given reasonable opportunity to inspect the warranted Tolko T-STRAND Pro OSB STR 1 Sheathing prior to any repair, replacement, alteration, or change, and (iii) all documentation has been submitted to Tolko within sixty (60) days after the claim is first reported. Upon request, Tolko must be provided with reasonable proof of product identification in the form of a Tolko T-STRAND Pro OSB STR 1 Sheathing panel sample, a photograph or a large identifying stamp, or a dated receipt. Written notification must be given by courier, email, or fax to Tolko, at the address provided below.

Exclusions from the Warranty

This warranty does not apply to any exterior application of Tolko T-STRAND Pro OSB STR 1 Sheathing or cover damage, claims, moisture absorption or defects in the Tolko T-STRAND Pro OSB STR 1 Sheathing, including delamination, warping, cracking or splitting due to or arising from:

- misuse or improper handling, storage, transport, installation, or maintenance;
- (ii) use of the Tolko T-STRAND Pro OSB STR 1 Sheathing other than as sheathing appropriate to the grade stamp on the panels;
- (iii) use of the Tolko T-STRAND Pro OSB STR 1 Sheathing that cannot be shown to comply with applicable building codes;
- (iv) alterations to the Building after the original installation of the Tolko T-STRAND Pro OSB STR 1 Sheathing;
- (v) acts of God or severe weather including rain, flood, tornado, hurricane, earthquake, hail or similar natural disaster;
- (vi) corrosive elements;
- (vii) damage caused by persons other than Tolko;
- (viii) mold and mildew, termites, or other wood destroying organisms; and
- (ix) installation workmanship or product modification.

Exclusion of other Warranties, Express or Implied

Other than this warranty, Tolko T-STRAND Pro OSB STR 1 Sheathing is sold "as is" and "with all faults". The warranties and remedies provided above apply to the Builder and Owner only, are transferable for 50 years, and are the sole and exclusive remedies except as otherwise required by law, and are made in lieu of and to the exclusion of all other conditions and warranties, express or implied, including but not limited to statutory or other conditions and warranties of merchantability or fitness for a particular purpose. Tolko will not be liable for any special, indirect, incidental, consequential or punitive damages, including without limitation, lost profits, loss of use or any other type of damages regardless of the theory under which such damages are sought.

Other Rights

This warranty confers specific legal rights. The Builder and the Owner may have other rights, which vary from province to province and from state to state

Governing Law and Attornment

This warranty is governed by and will be construed in accordance with the laws of the Province of British Columbia and the laws of Canada applicable therein. Tolko, the Builder and the Owner shall each attorn to the jurisdiction of the courts of the Province of British Columbia with respect to any dispute arising under this warranty.

- [2] In compliance with the current recommendations of Tolko (refer to Tolko website for "current recommendations") and APA The Engineered Wood Association and good engineering practices.
- [3] Delaminate means an extensive physical separation of strands within the Tolko T-STRAND Pro OSB STR 1 Sheathing that results in a material reduction in the structural properties of the panel. Minor surface imperfections such as localized checking or loose or folded strands on the panel surface do not constitute delamination.
